

Guidelines for the authors of post-conference monographs Multidimensionality of the health

The monograph can contain review and original papers on topics consistent with the subject of the conference. The cost of printing one paper in a monograph is PLN 145.00. The article will be published only after the fee for print of the work submission and sending the authors' statement (text below). Articles prepared not in accordance of the Terms of Use will not be sent back to the authors.

The work will be subject to review by experts in the field. Editorial Board reserves the right to make minor changes, graphics and layout of text that do not affect the content of the substantive work without the agreement of the author. The publication of the work in the monograph will not pay royalties. The first author of the chapter will receive one copy of the monograph without incurring the costs of its purchase (it will be sent by post The article submission by the author of the publication is tantamount to a statement that this work has not previously been published or submitted in the editorial office of another journal.

The paper should concise a minimum of 20 000 characters with spaces (without summary), but no more than 23000.

Layout of work:

- The title page should contain in sequence:

Surname, first name, title / academic degree

Affiliation (name of the institution where the work was prepared and developed)

The title of the work (in Polish and English)

Address for correspondence, telephone, e: mail

- Summary in Polish
- Summary in English
- ✓ in the summary of the review: Introduction, Aim, Body, Summary, Key words (3-5),
- ✓ in the summary of the original work: Introduction, Objective, Material and Methods, Results and Applications, keywords (3-5),

(the summary should contain from 200 to 250 words)

- Text

Original work:

Title of the chapter, Introduction, Aim, Material and Methods, Results, Discussion (discussion of the results), Conclusions, References - in the order of quoting

Review paper:

Title of the chapter, Introduction, Aim, Body, Summary, References - in the order of quoting

The text should be written in font 12 Times New Roman, title in bold font 12, text justified to the right, line spacing 1.5, margins - upper 2 cm, bottom 2 cm, left 3 cm, right 2 cm, pages numbered in the lower right corner all distinctions of the text, e.g. bold, are unacceptable, only Latin names should be distinguished in italics

- <u>References in the order of quoting</u> (Vancouver style) should be placed in square brackets with the number e.g. [2]. Each entry should contain the following items: - surname and initial of a first name, title, publishing house (or magazine name), (or issue of the journal), pages no, city / state, year of publication.

Example:

- Przybylska D., Kurowska M., Przybylski P, Obesity and overweight in the developmental population, "Hygeid Public Heath" 1: 28-35, 47, 2012
- Kostka T., Rehabilitation and physical activity of elderly people [in] Galus K. (red), Geriatria. Selected issues, Publisher Elsevier Urban & Partner, 277-287, Wrocław 2007

Websites must have a date of an access, (e.g.: access: 15/02/2018)

- Figures (photographs, graphs are treated as figures) in color, gray or black and white, should be centered, same as title of the figure, font 12, source font 10 placed under the figure.
- Tables should be centered, with the title above also centered font 12, the source under the table font 10. Headings centered, left-aligned text, right-aligned numbers, text in table in font 10.

Each figure and table should be referenced in the text. The reference should contain the number of the figure and the table. For recording we use the abbreviations: tab., fig.
