

AGREEMENT

BUSINESS SCHOOL, UNIVERSITY OF HUDDERSFIELD AND PANSTWOWA WYŻSZA SZKOŁA ZAWODOWA W SKIERNIEWICACH

1. AGREEMENT

This Agreement is dated *10 November 2008* and is made between:

- ◆ The Business School, University of Huddersfield whose principal office is Queensgate, Huddersfield, HD1 3DH, UK

- ◆ Panstwowa Wyższa Szkoła Zawodowa (PWSZ) whose principal office is ul. Batorego 64 C, 96-100 Skierniewice, Poland

2. PURPOSE AND SCOPE OF THE AGREEMENT

- a) This Agreement aims at developing cooperation in training, education research and other activities between the Business School, University of Huddersfield and Panstwowa Wyższa Szkoła Zawodowa w Skierniewicach.

- b) This Agreement makes possible the award of a BA (Honours) degree in named subjects to students from the partner university.

3. PERIOD OF AGREEMENT

This Agreement shall be of no effect until it is signed on behalf of both parties. Subject to this condition, the Agreement shall operate until termination by either party giving to the other not less than twelve calendar months' notice in writing, providing outstanding commitments are honoured and the rights of students currently enrolled due to this Agreement are safeguarded.

4. OBLIGATIONS OF BOTH PARTNERS



- i. The number of students enrolled according to this Agreement has to be agreed by both parties before the beginning of each academic year.


- ii. Students of the above mentioned study programmes, enrolled by one partner and having successfully completed the first two years there, are then allowed to be enrolled by the second partner, subject to the established and agreed entry requirements, to complete the ensuing year and to obtain (in case of success) the BA (Hons) degree.

- iii. The University where the student has been originally enrolled has a right to define specific conditions he/she must fulfil to obtain the degree from this University.


- iv. English is the language of students under this Agreement.
- v. Students are bound, by the agreement, to comply with the University fee arrangements for bachelor programmes.
- vi. Students of the above mentioned study programmes will cover all expenses such as: travel, board and accommodation, cost of insurance, etc.
